#### 3. Comparative evaluation of the candidates and the jury

The comparative evaluation of candidates will be carried out by a Commission appointed according to the Regulations and will consider:

- c) any additional specific elements of specialization which are proved by publications, studies, etc. (to be specified in the notice).
- The Evaluation Commission reserves the right to invite applicants for an interview to ascertain the skills of the activities covered by the contract.
- The Commission also reserves the right to review the qualifications and publications mentioned in the lists.
- The Evaluation Commission also reserves the possibility not to award the contract if none of the applications received is suitable for carrying out the tasks.
