## **3. Comparative evaluation of the candidates and the jury**

The comparative evaluation of candidates will be carried out by a Commission appointed according to the Regulations and will consider:

- c) any additional specific elements of specialization which are proved by publications, studies, etc. (to be specified in the notice).

The Evaluation Commission reserves the right to invite applicants for an interview to ascertain the skills of the activities covered by the contract.

The Commission also reserves the right to review the qualifications and publications mentioned in the lists.

The Evaluation Commission also reserves the possibility not to award the contract if none of the applications received is suitable for carrying out the tasks.


